

It is absolutely forbidden:

- Leave the paths during your visit, walk on the flowerbeds or access the working areas.
- Touch, handle, cut, pick or eat any part of the plants.
- Climb the trees or plants.
- Scale the architectural elements, the Pavilion, the handrails, etc.
- Bring in animals: dogs, cats, reptiles, birds, etc. (except guide dogs).
- Enter the garden on a bicycle, skates or a motor vehicle (except a wheelchair).
- Use drones.
- Play ball, practise sports or use any thrown objects.
- Smoke in the whole garden (except in the bar area).
- Bring in any alcoholic drinks.
- Drop rubbish, papers or any other waste outside the litter bins or the designated areas.
- Use mobile phones, radios or any other sound equipment which might disturb other visitors.
- Feed animals.
- Drink water from the fountains, ponds and decorative elements other than the specified ones.
- Make a fire.

The Carl Faust Foundation

The Carl Faust Foundation is a non-profit institution created in 1951 by Carl Faust with the following purposes: "... to protect and encourage the study of Mediterranean biology, especially botany, [...], seeking cooperation and international relations for the benefit of scientific research and dissemination...".

The Marimurtra Botanical Garden, classified as a Cultural Asset of National Interest by the Generalitat de Catalunya, is a private entity and is kept in perfect condition thanks to the fees charged to visitors, photography taxes and other uses of the place such as shootings, concerts or event hosting.

What is a photography tax?

At the Marimurtra Botanical Garden we apply this photographic tax when photographs are taken for personal use different than the usual photographs of the visitors of the Garden.

What are the most common cases?

Reports of weddings, communions, baptisms, family photographs, etc. or any other group who meet the aforementioned requirements.

Rate: 60 €

It includes: admission for 1 photographer (professional or not) + 3 people.

Every extra person of the group: 13 €

The photography tax entitles you to take pictures in any of the accessible areas of the garden, which will not be closed to the public.

What is a shooting?

It is a use of the Botanical Garden differing from a private visit. It implies that a professional will take pictures or record videos for commercial uses.

What is a commercial use?

- Public dissemination of the images.
- Use in catalogues, brochures and any other corporate communications materials.
- Any use by which the image of Marimurtra enhances the image of who is carrying out the shooting.

Use of drones

ESA's state law clearly establishes the limits to the uses of drones in public spaces. Therefore, every time the use of a drone will be requested within the Marimurtra Botanical Garden, it will be necessary to:

- Notify it before the presence of one of these aircrafts will be detected.
- Present an official pilot's license for drones issued by ESA.
- Furnish certification of the corresponding civil liability insurance.

The law does not allow images to be recorded in public spaces where there are two or more people. Therefore, recording with drones in areas open to the public during the opening hours of the Marimurtra Botanical Garden is absolutely prohibited.

Express permission of the Management is required to record images with drones inside the Marimurtra Botanical Garden.

In case of not having the requested permission, the Carl Faust Foundation reserves the right to take legal action against those unlawfully using the garden's facilities.

At the entrance of the Marimurtra Botanical Garden you can only hire the photographic canon service. For any other contract, you must first contact the Commercial Department:
